### **1. PRODUCT DESCRIPTION:**

#### **LOCTITE UK 8103 B30 / LOCTITE UK 5400**

Two-components polyurethane adhesive LOCTITE UK 8103 B30 (resin) and LOCTITE UK 5400 (hardener).

Mixing ratio by weight (resin/hardener): 5:1

Maximum surface weight: 268 g/m<sup>2</sup>

Tested color: brown

Tested applied [application rate 255 g/m<sup>2</sup> ( $\pm 5\%$ )] on a 25 mm thick calcium silicate board with density 950 kg/m<sup>3</sup>.

### **4. APPLICATION / LIMITATION:**

4.1 - Adhesive **LOCTITE UK 8103 B30 / LOCTITE UK 5400** may be used in the construction of "A", "B" and "C" Class divisions with a maximal application rate of 268 g/m<sup>2</sup>.

4.2 - Approved material is considered as having low flame spread characteristics (as per IMO 2010 FTP Code Part 5).

### **5. PRODUCTION SURVEY REQUIREMENTS:**

5.1 - This certificate alone does not allow the applicant to issue the Declaration of Conformity and to affix the mark of conformity (wheelmark) to the products corresponding to this type.
